

# Corporate structure



## Notes:

1. Singapore Petroleum Sampang Ltd ('SPS') is a wholly-owned subsidiary of SPC Production Company Ltd. SPC Production Company Ltd holds 100% in SPS through its two wholly-owned Cayman Islands subsidiaries which each holds a 50% equity interest in SPS.
2. Pursuant to a Sale and Purchase Agreement dated 29 November 2006, Singapore Petroleum (China) Private Limited has sold its 50% equity interest in Jiangmen City Sinjiang Gas Co. Ltd. The share sale transaction is expected to be completed in the first quarter of 2007.
3. PT. Sumber Prestasi Cemerlang is a wholly-owned subsidiary of Singapore Petroleum Venture Private Limited ('SPV'). SPV holds 50% directly and the remaining 50% is held by SPV's wholly-owned subsidiary, Singapore Petroleum (Indonesia) Private Limited.
4. Pursuant to a Share Purchase Agreement dated 12 March 2007, SPV has sold its 40.2% equity interest in Tiger Oil Corporation. The share sale transaction is expected to be completed in the first half of 2007.
5. Singapore Petroleum (Thailand) Co., Ltd. is a wholly-owned subsidiary of SPV. SPV holds 99.98% directly and the remaining 0.02% indirectly through its six wholly-owned British Virgin Islands subsidiaries namely Fullca Ltd., Glory Key International Limited, Orient Wise Group Limited, Prime Sea Limited, Straits Management Ltd. and Topwish Investments Ltd.
