

## **TERMS & CONDITIONS FOR <FUEL UP, WIN BIG> NETWORK PROMOTION**

The < **Fuel Up, Win Big** > (“**Promotion**”) is jointly organised by Singapore Petroleum Company Limited (“**SPC**”) and United Overseas Bank Limited (“**UOB**”).

### **Terms and Conditions applicable to this Promotion:**

1. This Promotion is open to all registered SPC&U and PDVL/TDVL Members (“**Participant(s)**”). Participants must present its SPC+ mobile app or SPC&U Card or PDVL/TDVL Sticker at the point of payment, and by doing so, they have agreed to the Promotion’s Terms and Conditions.

Participant who uses UOB Credit/Debit Card (Visa/Master/American Express®/UnionPay) (“**UOB Card**”) for his/her payment will have double Lucky Draw chances. Participant who fuels LEVO 98 will have 3 Lucky Draw chances for every S\$51.00 nett spend in a single receipt and if he/she uses a UOB Card to make payment, it will have 6 Lucky Draw chances.
